1. United Nations General Assembly: Prominent Stage, Limited Powers

- ☐ Every year, the opening session of the United Nations General Assembly (UNGA) becomes the stage where presidents and prime ministers give speeches.
- This becomes a platform for hate speech, criticism of other countries and self glorification by other leaders
- The event offers plenty of star power, but critics contend that it is little more than a glorified gabfest.
- Also, UNGA has no control over veto power exercised by UNSC and it cannot take any decisive action against permanent members of UNSC

2. United Nations Security Council: Powerful but Often Paralyzed

☐ The 15-member Security Council is by far the most powerful arm of the United Nations.

☐ It can **impose sanctions**; However, the veto power is used by permanent five countries to serve the strategic interest of themselves and their allies.



3. United Nations Secretary General: Global Reach, Vague Role

- ☐ The duties of the secretary general are vague in nature
- ☐ He or she is expected to show no favoritism to any particular country, but as the office is largely dependent on the funding and the good will of the most powerful nations, it hampers the working of the office



4. World Trade Organization: Stalled Negotiations

- The World Trade Organization is mandated to expand the free trade agenda and a standard bearer for open and efficient global markets.
- However, the advanced countries are determined to promote the kind of corporate-friendly rules that align with their own economic interests
- Regional Trade Organisations like NAFTA, European Union, ASEAN were added due to failure of WTO







5. International Court of Justice

- ☐ The International Court of Justice is the principal judicial organ of the UN that caters to legal proceedings between member countries
- ☐ Its judgement is not enforced. It cannot force states to abide by its decisions
- ☐ It mostly gives advisory opinions on legal questions referred to it by authorized UN organs and specialized agencies

6. World Climate Accord

- ☐ The Paris Agreement is an extended arm of the UN dealing with greenhouse-gas-emissions mitigation, adaptation, and finance, signed in 2016
- However, the US walked out of it and the other countries are not implementing it, despite signing it



7. World Health Organization: Arm Twisting by Rich Countries

- ☐ WHO was mandated to control the spread of contagious diseases, backstop public health programmes, formulate standards on nutrition and hygiene and establish a centre for comparative health data.
 - Recently, the World Health Organization (WHO) has been criticized by the US on account of mishandling of the Covid-19 pandemic and subsequently suspended its financial contribution to WHO
 - Polio, was eradicated from India without the support of the UN. Africa faced a health crisis which still needs to be addressed
- Since 1950, India has led a massive immunization programme for smallpox and other diseases and has been successful without the help of the WHO

8. Non - Proliferation Nuclear Treaty

- It is a treaty of the USA and not the UN (now do we say more !!)
- NPT is a biased treaty as only the 5 funding members namely The US, China, France, UK and Russia are given access to have or produce nuclear weapons




Reasons why the UN in its present form is losing its relevance:
